

Commence at the Southeast corner of the Southwest corner of said Section 20; run thence N00°09'01"W 289.52 feet along the East line of said southwest 1/4 to the southerly right-of-way of the Canadian Pacific Railroad; run thence S83°05'04"W 1158.25 feet along said railroad right-of-way to the point of beginning of this description; continue thence S83°05'04"W 35.24 feet along said railroad right-of-way; thence N00°06'46"E 99.70 feet to the northerly right-of-way of the Canadian Pacific Railroad; N83°05'04"E 35.24 feet along said railroad right-of-way; thence S00°06'46"E 99.70 feet to the point of beginning.
